# BID RFI NO. 6

1. Ref. Section 055000.2.7.B; Is Security Mesh to be primed or un-primed steel?

#### <u>Response</u>

Expanded metal at security walls can be un-primed steel.

2. The glazing specification & storefront specification lists the insulated glass at SF-1 & door 101a to match existing. It appears that the existing storefront frames have tinted glazing. Can a glass make-up be provided?

# **Response**:

Provide insulated glass to with a tint to match existing exterior. Provide sample per specifications to Architect to verify color matches existing.

3. Note 08 12 01 on the floor plan (A101) reads that glazing in hollow metal frames is to be 1 way mirror. The window schedule does not show B1 & B2 windows having one way mirror. Can you please clarify if type B1 & B2 windows are to be one way mirror?

#### Response

Window type B1 & B2 should be glazing type 2, refer to Addendum 3 for corrections.

4. What is Glazing type for SF-3?

# Response:

Storefront 3 is supposed to be glazing type GL-1, refer to Addendum 3 for glazing clarifications.
