Time of Completion and Liquidated Damages

Bidder hereby agrees to commence work under this Contract on the date to be specified in written "Notice to Proceed" of the Owner, and to fully complete the project within **49 calendar days**.

Bidder further agrees to pay to the Owner, as liquidated damages, the sum of **two thousand dollars (\$2,000.00)** for each and every **calendar day** that the work remains incomplete beyond the time specified for milestone dates and completion as hereinafter provided in the Contract Documents.

In addition, Bidder must agree to pay the Owner as liquidated damages the sum of **ten thousand dollars (\$10,000.00)** for each and every calendar day the work in **Work Area II** remains incomplete beyond the specified times for each work area.

Bidder acknowledges receipt of the addenda shown on the attached form entitled, **ACKNOWLEDGMENT OF ADDENDA**.

Bidder agrees to perform all the work described in the specifications, shown on the plans or directed, for the following unit prices:

2. CONTRACTOR will furnish all of the material, supplies, tools, equipment, labor and other services necessary for the construction and completion of the PROJECT described herein.

The CONTRACTOR will commence the work required by the CONTRACT DOCUMENTS on or before a date to be specified in the NOTICE TO PROCEED and will complete the work within the **49 calendar days** from the effective date of the NOTICE TO PROCEED unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
